SHED ALAM KHAN): (a) Vayudoot was set up to provide air-links to inaccessible  $_{a}re_{as}$  in the North Eastern Region and also to connect centres of commercial and tourist importance not included in the Indian Airlines' net-work.

Kb) and (c) Air services to Shillong, Cooch-Behar and Tezu, out of the 14 stations in the North Eastern Region identified for airlinking by Vayudoot, are already in operation Vayudoot services to Rupsi Kamalpur and Kailashahar provided earlier had to be dispoor continued due to very load factor. Vayudoot services were also extended to Aizawl, but have been temporarily suspended as repairs are being carried out on the run-way. Vayudoot services to the» remaining stations including Along, Zero, Daparijo, Passighat and Itanagar will be •considered after augmentation of the aircraft capacity and development of necessary infrastructure at these stations. It ig not possible, at this stage, to indicate the time-frame by which Vayudoot services will be provided to these stations.
