#### Railway Reforms Committee

Will the Minister of RAILWAYS be pleased to state;

(a) whether it is a fact that the Railway Reforms Committee has recommended the regrouping of the Indian Railways into 12 zones instead of the present nine zones and also creation of new divisions;

(b) if so, what are the details thereof; and

(c) what decision Government have taken in this regard?

THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHOUDHURY): (a) and (b) The Railway Reforms Committee in their recent Report on Regrouping of Railways have recommended formation of four additional zones viz.- East Central Zone, North Western Zone, North Central Zone and South Western Zone. The Committee have also recommended formation of divisions at the following places:—

2. Bhopal . . . . (C. Rly.)
3. Malda . . . . (E. Rly.)
4. Ahmedabad . . . . (W. Rly.)
5. Rourkela . . . . (S.E. Rly.)

#### Increase in quota of kerosene to Kerala

(a) whether Government have received any request from the Kerala Government for increasing the quota of kerosene to that State;

(b) what is the present quota of the State and the quantum of increase requested;

(c) what action has been taken by Government on the request; and

(d) if the present quota has not been increased, what are the reasons therefor?

THE DEPUTY MINISTER IN THE DEPARTMENT OF ELECTRONICS AND IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI M. S. SANJEEVI RAO): (a) and (b) The Government of Kerala have recently requested for enhancement of the monthly kerosene quota of the State from 13,390 tonnes to 1<sup>5,000</sup> tonnes.

(c) and (d) An additional allocation of 500 tonnes and 1000 tonnes for July and for August, 1984, respectively, has been made for Kerala.
