Dhamsiri Project

2683. SHRIMATI OMEN MOYONG DEORI: Will the Minister of IRRIGATION be pleased to state;

(a) whether it is a fact that the Dhamsiri irrigation hydel project is being constructed in Arunachal Pradesh which is going to submerge a large area of Arunachal Pradesh;

(b) whether the Assam Government has taken any permission from the Arunachal Pradesh Government;

(c) if not, what are the reasons for which the barrage is being constructed;

(d) whether the Assam Government has received any information regarding objection of such construction before finalising the boundary issue;

(e) if so, what are the reasons for continuing the construction; and

(f) whether the Central Government propose to take up the matter with the Assam Government and stop construction till proper agreement between the two Governments is reached?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI HARI NATH MISHRA): (a) Dhamsiri Irrigation Project being executed by the Government of Assam, will not cause submergence of large area of Arunachal Pradesh. The water spread behind the bar-

rage is mostly confined within the river banks.

(b) to (d) The Government of Assam has obtained clearance from the Government of Arunachal Pradesh for commencing the work on the project. Subsequently Arunachal Pradesh intimated that the question of giving land to Assam for the proposed scheme would be examined after a decision on Assam—Arunachal Pradesh boundary is taken.

(e) and (f) Based on the earlier clearance by Arunachal Pradesh work on this project has been taken up. It may not be appropriate for the Centre to put a stop to the works. In view of small submergence and mostly confined to river banks it is expected that these issues will be sorted out by the States on bilateral basis.

Dihang and Subansiri Dam Projects

2684. SHRIMATI OMEN MOYONG DEORI: Will the Minister of IRRIGATION be pleased to state;

(a) whether it is a fact that the Dihang Dam Project and Subansiri Dam Project are going to submerge a large chunk of develop areas, including two District headquarters and several hundred villages, affecting one-sixth of the population of Arunachal Pradesh;

(b) whether the said projects are likely to create a problem for the local population and also affect the ecology to a great extent; and

(c) whether the Central Government propose to intervene in the matter immediately to stop or withdraw the investigation as per discussion held in Gauhati by the Union Irrigation Ministers with the Chief Minister of the North-Eastern States and commitment given by the Chief Minister of Assam?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI HARI NATH MISHRA): (a) to (c) The Brahmaputra Board has identified Dihang and Subansiri dam projects as important components of the Master Plan for water resources development of the

Brahmaputra basin. The reports of the projects prepared by the Board on the basis of the investigations carried out so far would require detailed examination from all angle including effect on ecology etc. before the Central Government could consider taking a view in the matter.

Minimum investigations necessary for completing these studies are only being carried out by the Board. The Union Minister for Irrigation during the review meeting of the Brahmaputra Board in February, 1984, has assured that implementation of the projects will not be taken up without consulting the Arunachal Pradesh Government.

Unani Medicines manufactured by the
Indian Pharmaceuticals Corporation Ltd.,
Mohan (U.P.) is enclosed (see below) if
Manufacture of Siddha medicines has not
yet commenced.

(b) During the year 1983-84, Ayurvedic
and Unani medicines weighting approxima-
tely 18,818 Kgs. and 25 Kgs. respecti-
vely were manufactured. Medicines worth
approximately Rs. 6,02,500/- were sold.
