Setting up of T. V. Stations in UP

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF PARLIAMEN-TARY AFFAIRS (SHRI H. K. L. BHAGAT): (a) As part of phased commissioning of tranismitters, one TV Transmitter is being commission- ed every day with effect from 1-7-84.

(b) In addition to & TV Transmitters already operational, including 3 commissioned after 1-7-84; 15 TV Transmitters are scheduled to be commissioned in Uttar Pradesh before October, 1984. In all there will be

23 TV Transmitters in the State by the end of the current year.

Computerised Telephone Directory

*2. SHRIMATI USHA MALHOTRA:

DR. LOKESH CHANDRA:

Will the Minister of COMMUNICATIONS be pleased to state:

(a) the names of cities in the country where computerised telephone directories are in operation; and

(b) by when Delhi will also have a computerised telephone directory?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI V. N. GADGIL): (a) A statement is laid on the Table of the House.

(b) In Delhi Telephone District, telephone directories are being brought out through computerised process starting from the 1973 issue of the directory.

Statement

The work of computerisation of telephone directories could comprise two parts—one, publication by computerised process and, second, computerisation of directory enquiry service, with the computerised information being utilised for publication of telephone directory.

English editions of telephone directories in the telephone districts of Bombay, Calcutta, Madras, Delhi, Bangalore, Ahmedabad and Hyderabad are being brought out through computerised process.

Computerised directory enquiry service is not yet in operation. This service '197' is being computerised at Lucknow and Hyderabad on experimental basis and this would also assist in publication of the telephone directory at these two stations.

Computerised telephone directory service would also be introduced in Bombay, Calcutta, Delhi and Madras with the installation of in-house computers at these four metropolitan stations.
