Boundary Problems of Assam and . Arunachal Pradesh

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRIMATI RAM DULARI SINHA): (a) Yes, Sir.

(b) and (c) The Survey of India has been authorised to demarcate the border between the two States. They have already demarcated the border and erected pillars in undisputed areas. However, difficulties are being faced with regard to demarcation in certain areas. Stray instances of intimidation of staff and local level tensions have been coming to notice. The Chief Ministers of Arunachal Pradesh and Assam have been meeting to fuse tension. The High Powered Committee meetings are being held to demarcate boundary with the such adjustments may be mutually agreed opon.
