Report presented to the Jha Committee by the Maharashtra Dairy **Development Department**

2901. SHRI **CHATURANAN** MISHRA: Will the Minister of AGRI-CULTURE be pleased to state.-

- (a) whether Government's attention has been drawn to a report from the Maharashtra Dairy Development Department presented recently to the Jha Committee which shows clearly that son-operation Flood Districts are faring better than operation Flood Districts despite long investments and grants given;
- (b) if so, the details of the findings; and
- (c) whether Government propose to institute high powered inquiry to look into the serious setback to the health of the villagers belonging to operation. Flood areas such as Kaka District despite highest loans and grants under operation, flood-I and II?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) and (b) The Committee was apprised of the efforts put and the progress made so far by the Maharashtra Government in the field of Dairy Development.

(c) The Ministry of Agriculture and Cooperation have no proposal to institute any inquiry to look into the alleged setback to the health of villagers in areas covered under Operation Flood I and H.

Siphoning of Milk from Villages to Cities

CHATURANAN 2902. SHRI MISHRA: Will the Minister of AGRI-CULTURE be pleased to state:

(a) whether it is a fact that due to siphoning of milk from villages to cities, there is a higher incidence of T. B. and infant mortality in the villages; and

(b) if so, what remedial steps Government have taken or propose to take in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) and (b) Milk and other agricultural products have traditionally moved from rural areas to urban areas. The Government 'is not aware of any report of scientific study to establish relationship between alleged siphoning of milk from villages to cities and higher incidence of T. B. and infant mortality rate in villages.
