## Conversion of Mtizaffarmir-Narkatiaganj Metre line into Broad Gauge

•57. SHRI ASHWANI KUMAR: Will the Minister of RAILWAYS be pleased to state what is the present position of (i) conversion of Muzafifarpur-Narkatiaganj line from metre to broad gauge and (ii) construction pf broad gauge line along the north bank of Sone from Dehri-On-Sone to Banjari and to Jadunathpur? THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHOUDHURY): Engineering-cumtraffic survey for conversion ol Muzaffarpur-Narkatiaganj line (160 kms.) from MG to BG was carried out in two parts in 1981-82.

Engineering-cum-traffic survey for construction of a BG line from Dehri-On-Sone to Banjari (36 kms.) and upto Pipradih (63 kms. from Dehri-On-Sone) has been completed recent-. ly. No survey has been done for rail line upto Jadunathpur.

Due to severe constraint of resources, the above mentioned rail lines will have to wait for consideration till resources position improves.
