(c) The road requirement according to the redevelopment plan proposed by the New Redevelopment Advisory Committee has been taken into account before allotting this hotel site to the NDMC.

(d) The NDMC have reported that the hotel is likely to be completed by the 30th June, 1985.

#### Price of wheat in Bihar

673. SHRI CHATURANAN MISHRA: Will the Minister of AGRICULTURE be pleased to state:

(a) what were the prices of wheat in Bihar in the months of May and June 1984 and to what extent it fell short of the price fixed by the Central Government!; and

(b) what steps Government have taken to stop distress sale of wheat by the peasants?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA):

(a) The wholesale prices of wheat of fair average quality in Bihar in the months of May and June, 1984 were generally above the procurement price of Rs. 152 per quintal fixed by the Government for the 1984-85 marketing season.

(b) The Government had made elaborate arrangements for the purchase of wheat at the procurement price.

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI PATTABHI RAMA RAO):
