December, 1983. The Government have decided to consider in consultation with the Central Trade Unions whether the present verification procedure needs any refinement in the light of previous experience and in the light of various suggestions and recommendations made\_ This, of course, is subject to the condition that any substantive change will need a formal approval of the Indian, Labour Conference. The Government have decided to convene a meeting of the representatives of ihe Central Trade Unio, Organisations in this regard.
