## Production of Drugs by M/s. Metroni Private Ltd.

- 723. SHRI MAND KISHORE BHATT: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state;
- (a) whether it is a fact that Ms. Metroni Private Limited is one of the largest producers of Metronidazole and Metronidazole Benzoxylate;
- (a) whether it is also a fact (hat this company is selling Metronidazole at a price of Rs. 310/- per kg whereas Government's approved price for the drag is very high;
- (c) what steps have been taken to recover the unintended benefits made by the producers of formuations based on this drug; and
- (d) what are the reasons for fixing such high prices of these two drugs, when the same are sold at low price and by when the prices of formulations will be fixed to market level in order to give relief to poor people of the country?
- THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VASANT SATHE): (a) Ms. Metroni Drugs Private Limited is one of the largest producers of Metronidazole. They are, however, not producing. Metronidazole Benzoxylate at present.
- (b) Ms. Metoni Drugs Pvt. Ltd- have orted that from November. 1983 to April, 1984 they sold Metronidazole at a price varying from Rs. 309/- per kg. to Rs. 321 - per kg.
- (c) Notices have been issued to manufacturers of formulations of Metronidazol. Some of them have responded. The process of recovery, if any, and collections of details is followed up in accordarice with the provisions of law.
- (d) Market prices may only give indication but may not fully reflect the true

cost of production. The price fixation/ revisions are made as per the provisions of Drugs (Prices Control) Order, 1979.

## **High Price of Proxyvon Tablets**

- (a) whether it is a fact that six tablets of Proxyvon are being sold at Rs. 4.84;

THE MINISTER OF' CHEMICALS AND FERTILIZERS (SHRI VASANT SATHE): (a) to (d) Proxyvon manufactured by M/s. Panama Industries and Laboratories, Bombay, is being sold at Rs 4.68 for 6 tablets. M/s. Panama Industries and Laboratories, Bombay, operating in the small scale sector, had not so far obetained price approval from the Government though their sales turn-over is renortedly higher than Rs. 50 lakhs: A Show Cause Notice has been issii'il fo tne company along with the directions to submit their application for price fixation of their product in accordance with the Provisions of Drugs (Prices Control! Order, 1979.
