(a) Government is aware that there is concentration of child labour in certain industries such as the Match industries in Tamil Nadu, Carpet industries in Jammu & Kashmir and Uttar Pradesh, Slate quarries in Madhya Pradesh, Diamond cutting Jndustries in Gujarat, Glass and Bangla industries in Utta_r Pradesh, Tea Plantations in West Bengal and Brassware industry of Uttar Pradesh

(b) Fo_r production of Soda Ash in this Complex, the raw materials required are Ammonia, Carbondioxide anj Chalk which would *te* obtained from the upstream plants. The upstream plants are yet to be commissioned due to equipment problems. The Soda Ash plant can be commissioned only after the upstream plants are commissioned and adequate power to run thg entire Complex becomes available.
