(b) whether the recommendations of Dr. M.S. Swaminathan Committee are being implemented and if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (DR. AKHILESH PRASAD SINGH): (a) Government is implementing various watershed development programmes namely (i) National Watershed Development Project for Rainfed Areas (NWDPRA), (ii) Soil Conservation for Enhancing Productivity of Degradad Lands in the Catchments of River Valley Project and Flood Prone River (RVP & FPR), (iii) Reclamation of Alkali Soil (RAS), (iv) Watershed Development Project in Shifting Cultivation Areas (WDPSCA) (v) Watershed Development Fund (WDF), (vi) Externally Aided Projects (EAPs), (vii) Drought Prone Area Programme (DPAP), (viii) Desert Development Programme (DDP), (ix) Integrated Wasteland Project (IWDP) and (x) National Afforstation & Eco-Development Project (NAEP) through different Ministries in the country for management and development of the degraded lands. Under these programmes since inception up to the end of X-Five Year Plan, about 51 million ha. of degraded lands is developed.

(b) Government has taken necessary action to expedite examination of the Revised Draft National Policy for Farmers and other recommendations. A conference of State Ministers for Agriculture and allied sectors was held on 22nd December, 2006 to discuss and obtain their views on the recommendations made by the National Commission on Farmers. While examining the reports as well as Revised Draft National Policy for Farmers it was observed that many recommendations of National Commission on Farmers are already under implementation through several initiatives and programmes/schemes launched.
