dents in all the four Regions of country. Service quality tests have been carried out on 328 STD routes during the period June. 84 to March, 85. Out of these STD routes tested, the call completion rate from telephone to telephone has been found unsatisfactory (less than cent) on 47 routes (Statement attached). It cannot be assumed that STD in these cities is defective since each city has a number of STD routes and tests are conducted on one route at a time and not on all the routes or the system as a whole
