Gold Recovered From Air India Boeing

676. SHRI J. P. GOYAL: SHRI RAMCHANDRA BHARADWAJ:

Will the Minister of FINANCE be pleased to state.

- (a) whether i_t is a fact that 1200 tolas of gold worth Rs. 30 lakhs was recovered from the toilet of an Air India Boeing 747 on 22nd March, 1985 at the Sahar international airport;
- (b) whether any persons have been apprehended in this connection; and
- (c) if so, what are the details in this regard?

THE MINISTER OF STATE IN THE OF FINANCE (SHR) MINISTRY JANARDHAN POOJARI); (a) As a reesult of search by Customs of Air India air-craft which arrived from Dubai/Abu Dhabi on 22nd March, 1985, two cloth belts, with specially-made compartments, were recovered from underneath the disposal tray placed inside the toilet room near the economy class. On examination, each cloth belt was found to contain 60 gold bars, totally weighing 1200 tolas and valued at Rs. 29.73 lakhs. The gold recovered has since been confiscated under the Customs Act, 1962.

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) (b) The Interim Committee (Committee of the Governors of the International Monetary Fund) was held on 17th April, 1985 and the Development Committee (Joint Ministerial Committee of the Governors of the IMF and IBRD) was held on 18th and 19th April in Washington. The meetings were attended by an Indian delegation headed by the Finance Minister. Issues relating to International Economic Cooperation with special focus on the developing world were discussed in these meetings. The nature of these meetings is however in the form of a continuing dialogue between the developed and developing world so as to arrive at a consensus on matters relating to international economic cooperation.

The press communiques of the Interim Committee and the Development Committee explain the position reached at the meetings.
