## Working of Handloom Export Promotion Council

586. SHRI GULAM MOHI-UD-DIN SHAWL. Will the Minister of SUPPLY AND TEXTILES be pleased to refer to the answer  $t_0$  Unstarred Question 309 given in the Rajya Sabha on the 19th March, 1985 and state:

THE MINISTER OF SUPPLY AND TEXTILES (SHRI CHANDRA SHEKHAR SINGH) (a) and (b) A number of factors such as agitation by the staff of the Council, litigations in the Court of Law, intrenal dissentions in the Commit-'ee of Administration had an adverse effect on the working of the Handloom Export Promotion Council. Most of the above problems have been resolved now.

(c) Registration work for handloom items has been restored to the Handlooms Export Promotion Council under the Import-Export Policy. 1985–88.
