Additional Power Capacity

898. SHRI KRISHNA KUMAR BIRLA.: Will the Minister of IRRIGATION AND POWER be pleased to state:

- (a) what is the overall achievement in the generation of additional power Capacity at the end of Sixth Five Year Plan period as against the target;
- (b) what are reasons for the shortfall, it any, in the target; and
- (c) to what extent the additional power generation capacity has bridged the gap between the demand and supply in the country?

THE MINISTER .OF STATE IN THE DEPARTMENT OF POWER (SHRI ARUN NEHRU): (a) During the Sixth Plan, 14226 MW additional generating capacity was commissioned against a target of 19666 MW;

- (b) The main reasons for short-fail in achieving the target are (i) Inadequate availability of funds; (ii) Deray in placement of orders; (iii) Delay in supply of plant and equipment.; (iv) Delay in completion of civil works; (v) Unsatisfactory industrial relations
- (c) The energy shortage during 1979-80 was 16.1 percent which came down to 6.7 percent in 1984-85, as a result of various measures taken including additional power generating capacity commissioned during the Sixth Plan.

Progammes to raise literacy in the Sixth Five Year Plan

THE MINISTER OF EDUCATION (.SHRI K. C. PANT}: (a) Details of programmes taken up during the Sixth Plan period to raise the percentage of literacy la the country, particularly in rural areas, .nd acheivements made there-under, are indicated below:

Rural Functional Literacy Project

Under this Centrally sponsored scheme, cent percent grants to the State Governments, Union Territory Administrations are sanctioned, 513 projects have so far been sanctioned. Priority was given to the educationally backward States and Districts.

Sqheme of Assistance to Voluntary Agencies working in the field of Adult Education;

> Under this Central Scheme, financial assistance is provided to registered voluntary agencies for undertaking projects of Adult Education Centres, post literacy and follow-up work, resource support and organisation of workshops and seminars at the national level in selected areas. Grants are given @ 75 per cent of the, administrative cost and @ 100 per cent of the Programme cost for undertaking field programmes on project basis. 513 Voluntary Agencies have been approved since the revival of the scheme in April, 1982.

Schemes of Adult Education and Extension Programme through Universities and Colleges;

The University Grants Commission has been assisting Universities and Collegies for implementing a Scheme of Adult Education Programme. At present, 74 Universities and 2082 colleges are participating in the Programme. Besides, Nehru Yuvak Kendras are also implementing the Adult Education programme through National Service Volunteers Scheme. Adult Education is also one of the programmes 'being undertaken by the National Service Scheme,.
