and two others damaged when a fire broke out in a goods train at the railway yard of the Tughlakabad station on the 20th April, 1985;

- (b) whether an enquiry has been made into the causes of the accident and if so, the findings thereof;
- (c) the extent of damage to life and property as a result of the accident; and
- (d) the steps taken by Government against recurrence of such accidents?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) On 20-4-1985 ammunition loaded in wagon No. 28604 exploded and con sequently the wagon caught fire during shunting operations in Tughlakabad Marshalling Yard. One more wagon which was adjacent to this also caught fire.

- (b) A Departmental Enquiry is being conducted into this accident. The Committee has not yet finalised its report.
- (d) This will depend on the findings of the Enquiry Committee.
