## **Solatium fund Authority**

## 819. SHRI M. BASAVARA JU: SHRI M. MADDANNA:

Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) what are the reasons for not giving adequate publicity to the Solatium Authority;
- (b) whether Government propose to enhance the amount of Rs. 1,80,000 for providing publicity to this Authority; and
- (c) the number of claims settled by the said Authority since its inception in October, 1982, with details in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): (a) Publicity to the Solatium Fund Scheme is being undertaken on a continuing basis. Besides dissemination of information through television and radio interview, Press releases have been issued at intervals. Three lakh wall-posters in this connection were got prepared through DAVP, in all regional languages and in English and distributed through usual DAVP channels.

Transport Commissioners in the States/U'.Ts. who had been supplied with full background materials for arranging publicity in vernacular lang-guages have also been taking necessary steps.

(b) For the purpose of publicity of Solatium Fund Scheme, an amount of Rs. 2 lakhs has been provided for the year 1985-86. This is in addition

to normal publicity through AIR/TV and the press.

(c) Solatium Fund Scheme is implemented through the State Govts. On the basis of information received from the States/UTs, 756 claim applications have been decided, out of which 453 claims qualified for award. An amount of Rs. 15.82 lakhs has been paid as solatium.
