THE MINISTER OF HOME AFFAIRS (SHRI S. B. CHAVAN): (a) Government have seen the news item.

(b) Strict vigilance is being maintained in this regard by the authorities.

#### Second Interim Report of the Kudal Commission on Gandhi Peace Foundation

THE MINISTRY OF HOME AFFAIR (SHRIMATI RAM DULARI SINHA (a) to (c) Yes Sir. Some cases of violation of the provisions of the Map Restrictions Policy of the Government by Association of Vocuntary Agencies for Rural Development (AVARD) have come to the notice of the Kudal Commission of Inquiry. These are still under investigation.

# Tehri Dam and Srinagar Hydel Project pending with the Department of Environment

- 1016. SHRI KAPIL VERMA: Will the PRIME MINISTER be pleased to state:
- (a) whether the Tehri dam project and the Srinagar hydel project are pending with the Department of Environment for approval;
- (b) if so, what are the hinderances in the way of approval and whether the Uttar Pradesh Government has been apprised of it; and
- (c) if not, by when the approval is likely  $t_0$  be sanctioned

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI VIR SEN): (a) Yes, Sir;

(b) and (c) The original proposal of the Tehri Dam project was approved by the Planning Commission in

1972 but was not taken up for implementation immediately by the State authorities. This proposal was sequently modified and when implementation was started, it evoked opposition from the local people. The project was, therefore, referred to the Department of Environment for appraisal for which an Expert Group was constituted in 1980. An Interim report was submitted by the Expert Group outlining clearly the steps and studies to be undertaken by various agencies including the project authorities. Some of the problems included existence of a deep seated Marh fault \* cutting across the dam axis. faults passing through the reservoir which raised the question of reservoir rim stability due to induced seismicity in a seismicically sensitive area. The absence of Master Plan for the rehabilitation of the oustees, catchment area treatment Command area development etc. were some of the factors needing close examination, Geomorphological studies as well as studies on seismicity and the effect of deep seated Marh-fault have been completed showing that considerable areas on the reservoir slops would require stabilisation. A study of flora and fauna in the area has already been undertaken and a final assessment of the seismic aspects in the region is be submitted by the School of Earthquake Engineering, Roorkee University very shortly. On the basis of all this information, the project will be considered and recommendations offered.

The Srinagar Hydel Project is one of the 23 hydro-electric projects proposed on the river Ganga and it was decided, in consultation with the Planning Commission, that the comulative impact assessment of these projects should be undertaken to ensure that effective remedial steps for the reatment of the catchment and the levelopment of the Command Area are taken up concurrently with the execution of the engineering project. Accordingly, the Planning Commis-

sion has constituted three Expert Groups to examine the geolugical socio-economic and cost benefit analysis aspects of the hydro-electric development projects in the area. reports of these Experts Groups are still awaited. Even so, on the assurance of the State Government, that catchment Area treatment will taken up on priority the Srinagar Project has been delinked from portfolio of 23 projects and a separate set of safeguards have been suggested to be incorporated during implementation of the project including preparation and execution of Alaknande Catchment area treatment Plan above the dam site. Additional safeguards for this project will be designed in consultation with the State authorities and representatives of the Planning Commission. The project has been approved in principle.

## Kidnapping of B.S.F. personnel by Bangladesh Rifles
