सूचना और प्रसारण मंत्रालय के राज्य मंत्री (श्री बी० एन० गाडगेल) : (क) और (ख) जी हां। गीत और नाटक प्रभाग के निदेशक का पद 1.12.1983 से खाली पड़ा हुआ है। सभ लोक मेदा आयोग ने इस पद को दो बार विज्ञापित किया था और उम्मीदवारों का इन्टरव्यू लिया था किन्तु उनमें से कोई भी नियुक्ति के लिए उपयुक्त नहीं पाया गया।

(ग) जी हां।

(घ) निदेशक से एकदम निचला केवल एक ही पद है। इसलिए निदेशक के पद को प्रोन्नति द्वारा भरना वांछनीय नहीं है। तथापि, निदेशक के पद के भर्ती नियमों में संशोधन करने का प्रश्न विचाराधीन है और यह प्रस्ताव है कि अन्य व्यक्तियों के साथ साथ निदेशक से एकदम निचले पद-धारी पर भी विचार किया जाना चाहिए बशर्ते कि वह पात्रता की शर्तें पूरी करता हो तथा उसका चयन हो जाने की दशा में उसकी नियुक्ति को पदोन्नति समझा जाना चाहिए।

Cancellation of Projects in Libya by NBCC

1157. SHRI BIR BHADRA PRATAP SINGH: Will the Minister of WORKS AND HOUSING be pleased to state:

(a) what are the reasons for cancellation or surrender of some of the projects in Libya by the National Buildings Construction Corporation (NBCC);

(b) what is the contract Value, description and location of each of the cancelled or surrendered projects;

(c) the reasons for loss in respect of each project undertaken by NBCC in Libya;

(d) the penalty due to delay, if any, required to be paid by NBCC in Libya;

(e) the payment due to NBCC in respect of each project and its Progress till March, 1985; and

(f) what new projects are expected to be signed in Libya in the near future?

THE MINISTER OF WORKS AND HOUSING (SHRI ABDUL GAFOOR):

(a) Some of the Projects were withdrawn by the clients due to non-approval of General Peoples Committee of Libya.

(b) Details are given in Statement-I.

(c) There has been loss only in the case of Ghat Airport Project undertaken by NBCC in Libya on account of time over-run on the project due to abnormal delay in Payment, restriction of Working hours and shortage of materials such as bitumen, cement etc.

(d) No penalty due to delay is levied on NBCC. The clients have withheld some amount which is likely to be released after grant of extension of time as requested.

(e) Details are given in Statement-II.

(f) Construction of public works for municipality of Al-Abiar is expected to be awarded in the near future.
