Activities of Foreign Charter Fishing Boats

1065. SHRI ADINARAYANA REDDY: Will the Minister of AGRICULTURE RURAL DEVELOPMENT be AND pleased to state:

- (a) whether it is a fact that numerous foreign charter fishing boats were surged off the coast of Kerala in 1984;
- (b) what steps are being taken by Government to protect small fishermen from foreign boats such activities by large permitted to use our waters;
- (c) whether Government propose to modify this policy in the interest of the fishing sector; and
 - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE OF AGRICULTURE AND MINISTRY (SHRI RURAL DEVELOPMENT CHANDULAL CHANDRAKAR): Eight foreign chartered vessels were prehended by the Coast Guard off the coast of Kerala on 26-7-1984 for fishing in waters below the prescribed limit of 40 fathoms.

(b) to (d) Chartering of foreign fishing vessels is governed by the provisions of the Maritime Zones of India (Regulation of fishing by foreign vessels) Act 1981

and the Rules framed thereunder. area of operation of chartered vessels is defined in the MZI Rules 1982 keeping in view the interests of the small fishermen. Violation of the statutory provision is punishable under the MZI Act 1981 which provides for fine, imprisonment of crew and confiscation of the vessels.

The operational details of the charter policy are reviewed from time to time and necessary changes have been introduced when found necessary.

Yield Ratio of Small and Marginal Farmers

1066, SHRI THANGABAALU: Wilt the Minister of AGRICULTURE RURAL DEVELOPMENT be pleased to state:

- (a) whether it is a fact that the yield ratio of small and marginal farmers continue to lag behind and the bulk of the total cultivated area is operated by small marginal farmers; and
- (b) if so, what are the details of the steps Government have taken to improve the productivity of the small holdings?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND RURAL DEVELOPMENT (SHRI. CHANDULAL CHANDRAKAR): The yield rates are not generated for samll and marginal holdings separately in crop cutting experiments Against the total area of 163 million hectar under all type of holdings, the area under small and marginal farmer's holding is about 43 million hectares which is about 26.3 per cent of the total area under all types of holdings.

(b) In order to improve the productivity of small holdings, under Centrally sponsored scheme of assistance to Small and Marginal farmers for increasing agricultural production, an annul outlay of Rs. 5 lakh per block has been earmarked with the following break-up:

Delhi Development Authority has allotted a site in Maurya Enclave for construction of a DMS booth. Construction of the booth will be taken up after the approval of Delhi Urban Arts Commission is obtained through Delhi Development Authority.
