

# Acquisition of Shares of M/s. Shaw Wallace and Co.

BIRLA:

Will the Minister of INDUSTRY AND COMPANY AFFAIRS be pleased to state:

(a) whether the Company Law Board has received any Memorandum from All India Shaw Wallace Employees' Federation, Calcutta, about the fake over bid of the Shaw Wallace & Company Limited, Calcutta.

(b) if so, what are the details thereof;

(c) whether the matter is still under investigation; and

(d) whether the person who has purchased major Block share holding of about 38.7 per cent has obtained the permission from the Reserve Bank of India?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY AND COMPANY AFFAIRS (SHRI ARIF MOHD. KHAN): (a) Yes, Sir.

(b) The allegation relating to take over bid mentioned in the Memorandum is about acquisition of 38.7 per cent shares of M/s. Shaw Wallace and Co. Ltd. by taking over R. G. Shaw & Co., London, a foreign company, by a non-resident Indian Shri M. R. Chhabria.

(c) The matter relating to ownership of shares in question is still under investigation under section 247 of the Act.

(d) It has been reported that no application has been received by the Reserve Bank of India for acquisition of 38.7 per cent shares of Shaw Wallace & Co. Ltd. held by R. G. Shaw & Co. Ltd., London and its subsidiaries.
