Sale of Bajaj and Priya scooters in black market

*192. SHRI SURESH PACHOURI: SHRI J. P. GOYAL:

Will the Miinister of INDUSTRY AND COMPANY AFFAIRS b? pleased to state:

- (a) whether it is a fact that 'Priya' and 'Bajaj' scooter, are being openly sold in the black market;
- (b) whether it is also a fact that most of the persons who book these scooters sell these in black at the time of taking their delivery;
- (c) whether it is proposed to scrutinise the booking of scooters to find out whether the booking has been made by genuine persons; and

(d) what measures are proposed to be taken to ensure that the persons who get scooter_s booked keep the same for their own use and do not transfer it to other persons and what penalty "i_s proposed to be imposed against the persons found guilty of violating the said provisions?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY AND COMPANY AFFAIRS (SHRI ARIF MOHD. KHAN): (a) Although possibilities of some such transactions cannot be ruled out, there is no specific information regarding this with the Government.

(b) and (c) No, Sir.

(d) There is a ban on resale of motorised two-wheelers including scooters within two years of the first purchase under the two-wheeler Vehicles (Restriction on Resale) Order, 1981. The State transport authorities de* not register transfer of these vehicles within the stipulated period of two years unless permission has been given by the Controller for such transfer^ Simultaneously Government has taken several steps to improve availability cf good quality two wheelers to meet projected demands.

Price Control of Drugs

*193. SHRI BHAGATRAM MANHAR:

SHRIMATI MAIMOONA SULTAN: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to refer t₀ the answer to Unstarred Question 23*3 given in the Rajya Eab'ia on the 18th March, 1985 and state:

(a) wheher it is a fact that the price control of drugs recommended by National Drugs and Pharmaceutical Development Council is not based on therapeutic groups;

- (to) whether it ia also a fact that the working group on pricing recommended for price control on therapeutic groups;
- (c) if so, how NDPDC have recommended price control on individual drugs and what are the basis of such recommendation;
- (d) how the objective of providing medicines at reassonable price can be achieved toy controlling the price- of individual drugs; and
- (e) the names of the drugs which presently fall under the Second Schedule of category III therapeutic-wise of the existing Drugs Price Control Order, 1979 which have been recommended by NDPCD for price decorrol?

THE MINISTER OF CHEMICALS AND (SHRI FERTILIZERS VEERENDRA FAT1L): (a) to (c) The final recommendations of the National Drugs and Pharmaceutical[^] Development Council have evolved through detailed examination in different Working Groups and subsequent evaluation, integration and consolidation undertaken by the Steering Committee of the NDPDC. The list of 95. priority drugs (list already furnished in answer to Unstarred Ouestion No. 130 answered on 21st January, 1985 has been finally recommended for price control based on assessment of Medical expert members of the NDPDC.

- (d) The objective which the NDPDC has kept in vjew in recommending smaller basket for price control is to ensure abundant supply of life saving and mass consumption drugs.
- (e) According to the recommendation of the NDPDC, all the drugs listed in First and Second Schedule to the Drugs Prices Control Order. 1979, except 95 priority drugs recommended by it, would not be in the basket of price control.
