

Delhi, have sought the release of the special Central assistance of Rs. 100 crores needed by the former Union Finance Minister of the State.

(b) if so, what action the Central Government have taken to release the same amount?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) and (b). Minister, Andhra Pradesh, during his visit to Delhi mentioned that the State did not receive any assistance for good financial management. He was informed that the scheme of providing special assistance to States that managed their finances well contemplated earlier was not pursued as most States including Andhra Pradesh closed the year 1983-84 with a continued overdraft with Reserve Bank of India in 1984-85.

Setting up of Public Sector Industries in Marathwada Region

1390. SHRI VITHALRAO MADHAV-RAO JADHAV: Will the Minister of FINANCE be pleased to state:

(a) what are the details of the big public sector industries which are situated in the eight districts of Marathwada region of Maharashtra State;

(b) whether it is a fact that public sector industries are at present established either in Bombay, Pune or Nagpur which are big cities;

(c) whether such a step will help in rural industrialisation; and

(d) whether Government have any proposals under their consideration to establish a public sector industry in any of the districts of Marathwada region of Maharashtra State?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) The information is being collected and a statement will be laid on the Table of the House.

(b) and (c) Since investments in industrial projects are primarily made on broad techno-economic considerations, central public sector units are presently by and large located in Bombay, Pune and Nagpur areas in Maharashtra State. However, subject to techno-economic considerations, the policy of the Government is to give preference to the location of industrial projects in backward and rural areas.

(d) As the Seventh Plan is still under finalisation, no details in this regard are available.

New Bonus Formula

1391. SHRI K. VASUDEVA PANICKER: Will the Minister of FINANCE be pleased to state:

(a) whether a new bonus formula is under formulation;

(b) if so, by when it is likely to be finalised; and

(c) whether Government also propose to amend the Bonus Act, 1965 keeping in view the announcement made by him during his Budget speech on the 16th March, 1985?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) and (b) The Payment of Bonus Act, 1965 does not apply to employees employed by an establishment engaged in any industry carried on by or under the authority of any Department of the Central Government or a State Government or a local authority.

Productivity Linked Bonus Schemes have, however, been introduced since 1979 for the Central Government employees working in various commercial and production-oriented sectors of the Government. In the case of the remaining Central Government employees, orders for payment of *ad-hoc* bonus for 1982-83 and 1983-84 were issued, pending evolution of suitable formulae. The question of evolving broad parameters for the various Productivity Linked Bonus Schemes is under consideration. It is not

possible to indicate at this stage the time by which it would be finalised.

(c) Necessary legislative action has already been taken by the Ministry of Labour in the current session of Parliament.

Reforms in Indirect Tax Structure

(i) whether a long term fiscal policy including reforms in indirect tax structure to convert the present sellers' market into a buyer's market when goods would chase the consumer have been under the consideration of Government in the light of Abid Hussain Committee's report;

(b) what are the main recommendations of the Abid Hussain Committee Report; and

(c) what action Government have taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) Outlines of a long term fiscal policy are in the process of formulation. Report of the Abid Hussain Committee deals with trade policy and does not directly deal with "the subject of long term fiscal policy.

(b) and (c) The Report of the Abid Hussain Committee is under consideration. It would not, therefore, be in public interest to furnish the salient features/detail of the recommendations.

Production of Coffee

(a) whether it is a fact that the production per hectare of coffee has gone down since 1982-83;

(b) if so, what are the reasons therefor; and

(c) what steps Government have taken or propose to take to increase the production of coffee?

THE MINISTER OF FINANCE AND COMMERCE (SHRI VISHWANATH PRATAP SINGH): (a) to (c) The production figures of coffee for the last three years are as under:

1982 1,29,514*
1983 1,04,624*
1984 1,80,000*

The short fall in production and productivity in 1982 and 1983 was due to belated blossom showers and prolonged drought conditions which prevailed in coffee areas. However, this has been compensated by a record crop of 1984
