#### India's share in textile import markets

1373. **SHRI ASHWANI KUMAR:** Will the Minister of **SUPPLY AND TEXTILES** be pleased to state.

(a) whether it is a fact that according to a report published by UNCTAD Secretariat for the year 1984, India's share in

textiles and clothing import markets is negligible;

(b) if so, what are the details of India's share in the above market during the last three years, year-wise;

(c) what was the share of India in clothing imports with respect to USA and each member state of EEC in each category and country where specific restraints were applicable during the last three years; and

(d) what are the details of global ceilings imposed by EEC in respect of each clothing category subject to specific restraints levels for India during 1985 and what is the share of India in these global ceilings?

THE MINISTER OF STATE OF THE MINISTRY OF SUPPLY AND TEXTILES (SHRI CHANDRA SHEKHAR SINGH): (a) and (b) According to (JUNCTAD Sectt. documents No. TD/B/C/2/215[Rev. 1, India's share in imports of select markets for Textiles & Clothing in 1981 was 2.15 per cent (including trade among EEC countries); 3.50 per cent (excluding trade among EEC countries). India's share in select markets during 1981 is given in the Statement. Details for other years are not mentioned in the aforesaid UNCTAD publication.
