1472. SHRI DHULESHWAR ME-ENA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether some new contraceptive devices have been developed by the Indian Council of Medical Research (ICMR) with a view to control population involving an injectable and a subdermal implants—and clinical trials to be dealt with separately; and
- (b) if so, the steps being taken to popularise their use particularly in the backward, rural and tribal areas by offering some incentives?

(a) and (b) Clinical trials on netOenenthatate—an injectable contraceptive, and Norplant—a subdermal silastic implant—which have been

developed in other countries, are being conducted by the Indian Council of Medical Research prior to their introduction in the National Family Welfare Programme.
