MW replacement units. The proposal of Tata Electric Companies instal another 500 MW unit Trombay has also been approved.

Compensation claims paid due to loss of life and property

1665. SHRI F M KHAN: Will the Minister of RAILWAYS be pleased to state the total amount on account of compensation claims paid during the last three calendar years on account of life and property in the railways?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): A sum of Rs. 284.42 lakhs has been paid as compensation during the last three calendar years i.e. 1982, 1983 and 1984 to the dependents of those killed, to the injured and for the loss personal belongings in accidents under section 82A of the Indian Railways Act, 1890.

Control of Diabetes

THE MINISTER OF STATE IN DEPARTMENT OF HEALTH (SHRI YOGENDRA MAKWANA): A new scheme entitled "Diabetes Control Programme" has been cluded in the Seventh Five Year Plan proposals of the Ministry of Health and Family Welfare. The intervention strategies are based on the basic premise that diabetic care should be part of primary health care programme. Health care personnel are to ensure imparting to the patients factual knowledge about diabetes specially about common, acute and chronic complications

(b) to (d) M|s. Heinrich Brand of West Germany has offered supply small container vessels Corporation India Shipping of alongwith finance of 90 per cent of

the cost, on long term basis, for the project. This offer was examined by Shipping Corporation of India and was not found suitable.
