THE MINISTER OF STATE IN THE DEPARTMENT OF HEALTH (SHRI YOGENDRA MAKWANA): (a) to Admissions in medical colleges (d) primarily controlled by the State/ Governments and Universities. UT The basis and extent of reservation of seats for Scheduled Castes and Scheduled Tribes in the medical colleges in the country vary from State to State. The Govt, of India have no information regarding reservation of seats in medical colleges in the country for students of Meghalaya or for students belonging 10 Scheduled Castes and Scheduled Tribes. Depending on the over-all availability of MBBS seats in the Central Pool, a certain number of MBBS seats are allocated each year to the Government of Meghalaya for nomination of their candidates.
