National Water Policy

1502. SHRI M. S. GURUPADASWA-MY: Will the Minister oi IRRIGA-TION AND POWER be pleased to state:

- fa) whether Government are pre-,iiy considering to formulate a National Water Policy;
- Ob) whether Government propose to give preference to internationally accepted principles in the formulation of the new policy;
- (c) if so, what steps Government have taken to solve the sharing of Cauvery waters among the basin States; and
 - (d) what are the details 'thereof?

THE MINISTER OF IRRIGATION AND POWER (SHRI B. SHANKARANAND): (a) and (b) The formulation of a national water policy involves complex issues which will be considered by the National Water Resources Council. While doing so, the Council will consider various principles for adoption in the national policy suited to the country.

(c) and (d) In regard to sharing of Cauvery waters, the Government of ui had convened a meeting of the concerned Chief Ministers in April 1983, where it was decided that Karnataka and Tamil Nadu would resume bilateral discussions to arrive at a mutual understanding after which a meeting of the Chief Ministers, of the Basin States would be conveyed by the Centre. Accordingly, Chief Ministers of Karnataka and Tamil Nadu met in January, 1984 and decided that as soon as the mutual exchange of data is completed they would hold further discussions.

- (g) by when the peasants are likely to be paid the compensation in full?

THE MINISTER OF STA^E OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z.R. ANSARI):
(a) to (g) The Government of India are primarily concerned with the roads declared as National Highways only. Since the road, in question, forms a part of State Road network, the State Government of Himachal Pradesh is responsible for the construction and ancillary matters.
