In accordance with the CSS (Promotion to Grade I and Selection Grade) Regulations, 1964. the Select List is prepared on the basis of the assessment of vacancies likely to arise between 1st July of the year for which the panel is prepared and 30th June of the following year. There is no proposal undei' the consideration of the Government for issuing of a Supplementary Select List.

Discharge of mercury bearing waste water by four caustic soda units
