- (d) A provision has now been made in the Act for the registration of recipient associations if they want to accept foreign contribution. If an association does not register itself with the Central Govem-ment it is required to seek prior permission for acceptance of foreign contribution in each and every occasion. In case an association which is registered fails to send intimation of receipt of foreign contribution in time or in the prescribed manner etc., the Central Government can require it to seek prior permission for ac-cetpance of foreign contribution on each and every occasion.
