  - 9. Inter-District meeting with the Police Officials of the adjoining States.

## Celebration of International Youth Year, by the Youths from Tribal areas

THE MINISTER OF STATE IN THE DEPARTMENT OF YOUTH AFFAIRS AND SPORTS (SHRI R. K. JAICHANDRA SINGH): (a) and (b) The-young people of tribal areas form an integral part of the youth of the country. The programmes envisaged for IYY to be undertaken nationally and by the State governments and union territory administrations are meant to include youth activities inter-alia, in the tribal areas. For example, an Adivasi Yuva Chetna Chal Samaroh and Adiavasi Yuva Gosthi were held as part of the observance of IYY. A national integration camp is being held in Darbhanga to which youth from'tribal areas have been invited. In the Tohhcom-ing All Rural Sports Tournament

and National Sports Championship for Women, a number  $_{o}i$  triSa? ^ybuffi 'ire expected to participate. It  $i_s$  also pro-posed later in the year to organise a tribal youth meet in Dehradun. Such activities are already taking place anad will continue during the Internationtal Youth Year and beyond. Recently, the State governments and Urion Territory Administrations have been asked to involve young people from tribal areas in youth programmes in a greater measure.

## Memorandum of Understanding on the Transfer of Technology beween USA and ndia

The MOU will cover all items on the US Commodity Control List and the Munitions List, and all controlled technical data on such lists.
