- (a) whether it is a fact that the cattle insurance scheme is at present limited to integrated Rural Development Project areas and the owners of cattle are not aware of it;
- (b) whether it is a fact that due to the foot and mouth disease, the owners of the cattle have to suffer huge losses in the rural areas; and
- steps (c) what Government are taking to set up more insurance branches in the villages for the insurance of cattle?

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVE-LOPMENT (SHRI **CHANDULAL** CHANDRAKAR): Cattle Insu-(a) rance Scheme is not limited to Integrated Rural Development Project Number of non-(IRDP) areas. I.R.D.P. animals under insurance cover is increasing year to year.

- (b) Food & Moutr disease 'results primarily in temporary loss in milk production, which can be prevented by periodic vaccination of cattle and buffaloes with vaccine available in the country. This disease is covered under Cattle Insurance Policy.
- (c) To cater to the needs of cattle owners in rural areas, Inspectors/ representative.s are being appointed in rural places and depending on viability branch offices are also being opened.
