- (a) whether the Village Industries Vikas Samiti, a voluntary tion, of Bairangpur has applied the execution of NREP/RLEGP works TRYSEM training programmes IRDP schemes in the District of Mayurbhanj;
- (b) if so, what action has been taken thereon; and
- (c) if no action has been taken what are the reasons therefor?

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVE-LOPMENT (SHRI CHANDULAL CHANDRAKAR): (a) to (c) Implementation of Rural Development Programmes is done by the State Governments. A communication received on behalf of the Samiti was passed on to the State Government for approprivate action.

Assistance is also provided to voluntary organisation by People's Action for Development (India) (PADI) for specific projects of rural development. On a communication from the Samiti, General Secretary, PADI, had sent relevant material to the Samiti on 8th May. 1985. No project from Sămiti, formulated in accordance with the guidelines of PADI, has so been received by PADI.

Selection Grade for Group 'D' Employees

- (a) whether his Ministry and Departments like the Delhi Doordarshan Kendra, Directorate General, Doordarshan Headquarters. Mandi House, New Delhi, AIR etc. have not implemented the guidelines issued by the Ministry of Finance on 10th January, 1974 and Ministry of Home Affairs on 1st November, 1977 vide O.M. No. 49017/2/76-Estt(C) regarding introduction of 20 per cent post/ selection grade for peons, daftries, safaiwalas/frashs in Group D;
- (b) if so, the names of the offices Departments which have not yet implemented in full the above guidelines;
- (c) the number of Group D employees in each category Department. wise in the same cadre with over 8 years of service; and
- (d) what steps Government pose to take to ensure that the 20 per cent posts of selection grade in Group 'D' are given by each Department?
