THE MINISTER OF STATE IN THE DEPARTMENT OF STEEL (SHRI K. NATWAR SINGH): (a) Till 31st March 1985, 95 vessels were allotted to ship-breaking units at Alang in Bhavnagar District of Gujarat. 70 vessels have been broken completely and remaining 25 are under breaking.

(b) Metal Scrap Trade Corporation Limited as a canalising agency has ensured imports of foreign flag ships for scrapping at competitive prices and their equitable distribution amongst the shipbreaking units in the country. Besides, MSTO has provided financial assistance in the snap* of bill discounting facility and technical assistance to the ship-breaking industry.
