## Applicatious for LPG connections in Kerala

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHARMA); (a) There were approximately 33,840 persons on the waiting lists with various distributors of oil companies in Kerala for LPG connections as *On* 31st December, 1984.

- (c) Does not arise.
- (d) Refill supplies of LPG in the Southern Region including Keraia were disrupted following closure of the Cochin Refinery after the fire accident in March, 19M. With the Refinery resuming production there is considerable improvement in the position and refills are now supplied within a week.
