- (ii) Customs duty on imported pulp and wood chips totally exempted.
 - (iii) Customs duty on wood in certain specified forms has been reduced from 100 per cent to 10 per cent.
 - (iv) Import duty on waste paper used for paper-making has been waived.
 - (v) Flexibility has been given to the paper industry for production of any variety of paper and paper-grade pulp including paper board/straw board within the licensed capacity in line with the market demand.
- (d) The production of paper and paper board in 1984 was 14 lakh tonnes, which more or less matches the consumption.

(c) and (d) The proposal for an oil terminal at Paradip has been under consideration but does not form part of the approved projects during the Sixth Five Year Plan.
