THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHARMA): (a) to (d) According to the information made available to Government. between Junc. 1984 and February, 1985, M/s. Prem Nath Motors Private Limited did not directly receive any complaints regarding under-weight LPG cylinders supplied by them. Ten complaints including one sent from the Ministry of Petroleum, were, nevertheless, received during this period by the Indian Oil Corporation against M/s. Prem Nath Motors' Private Limited about supply of under-weight LPG cylinders. These complaints were enquired into by the Corporation and all of them were found to be correct. The consumers concerned were suitably compensated in each case. The distributor was issued warnings/ show cause notice and was cautioned to improve the performance,

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHARMA): (a) and (b) At present the requirement of kerosene of each State Union Territory is assessed by allowing 5 per cent growth over the allocations made during the corresponding period of the previous year on a four month block basis,

To review the present system of allocation and to advise Government about the rationale to be adopted for kerosene allocations to the States, a one-man Committee has been appointed. This Committee is expected to submit its report by July, 1985.

A statement giving allocations sales made to each State/Union Territory during the years 1982, 1983 and 1984 is enclosed as Statement. The time and labour involved in furnishing month-wise details for the three years may not commensurate with the objective proposed to be achieved.
