THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI (a) The NAWAL KISHORE SHARMA): marketing oil companies make appointments of LPG distributors on the basis of recommendations received from the Oil Selection Board concerned. Ιn making selections from among eligible candidates, the Oil Selection Boards take the following factors into account:

- 1. personality;
- 2. business ability/salesmanship;
- 3. capacity to arrange finance and capability to provide facilities.
- 4. Preparedness for working full time as a dealer; and
- (5) general assessment and extra-curricular activities.

## Price fixation of Baralgan Ketone

- (a) whether Hoechst Pharmaceuticals a multinational company declared price of Baralgan Ketone under Drugs price Control Order, 1970, if so, what was the price declared per kg, and when was

this intimated to this Ministry and what is the price fixed;

THE MINISTER OF CHEMICALS AND FERTILIZERS AND INDUSTRY AND COMPANY **AFFAIRS** (SHR1 VEERENDRA PATIL): (a) to (c) M/s. Hoechst Pharmaceuticals Limited have reported that they declared in June 1970 a price of Rs. 23,625]- kg. based on the export price and that after commencement of commercial production they reduced it to Rs. 8019 - per kg. 1977. The Government fixed price is Rs. 1810.20 per kg. with effect from 31st December, under DPCO 1979. Before the prices the formulations based on the revised price of the drug as announced by the Government could be revised the Delhi High Court granted a Stay to the Company by virtue of which they were able to maintain the pre-revised prices drugs and formulations. The Delhi High Court in its final judgement in December, 1984 set aside the Government Order fix ing the price of the bulk drug under DPCO 1979, Special Leave Petition and Application for Stay against the Delhi High Court Judgement have been filed in the Supreme Court.
