(e) Self-sufficiency has been achieved to the extent of 69 per cent. Since exploration for oil is highly probabilistic in nature, it would not be possible to indicate with any certitude, the period by which self-sufficiency in oil can be attained.

Demand and supply of Kerosene to States

203. SHRIMATI IILA BHATTACHARYA: Will the Minister of PETROLEUM be pleased to state:

(a) what is the demand for kerosene in different States with State-wise details thereof during the last 3 years;

(b) what is the allotment quota of each State for kerosene, with month-wise details thereof during the last three years, and what is the actual supply to the States, State-wise and month-wise during the above period;

(c) whether there is any gap between the demand for and the supply of kerosene in the country;

(d) if so, what are the reasons therefor; and

(e) what steps Government propose to take to remove the gap?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHARMA): (a) and (b) At present the requirement of kerosene of each State/Union Territory is assessed by allowing 5 per cent growth over the allocations made during the corresponding period of the previous year on a four month block basis.

To review the present system of allocation and to advise Government about the rationale to be adopted for kerosene allocations to the States, a one-man Committee has been appointed. This Committee is expected to submit its report by July, 1985.

A statement giving allocations and sales made to each State/Union Territory during the years 1982, 1983 and 1984 is enclosed as Statement. The time and labour involved in furnishing month-wise details for the three years may not commensurate with the objective proposed to be achieved.

(c) As can be seen from the attached statement, the sales have been largely in keeping with the allocations.

(d) and (e) Do not arise.
