## Parallel circulations of paper coins in Gujarat

\*84. SHRI O. J. JOSEPH; Will the Minister of FINANCE be pleased to state:

- (a) whether Government are aware that parallel circulation of paper coins printed by traders of Gujarat are in wide use;
- (b) whether Government propose to take steps to curb circulation of such paper coins;
  - (c) if so, what are the details thereof; and
  - (d) if not, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JANARDHAN POOJARI): (a) The Reserve Bank of India have reported that certain establishments like shops, hotels etc. are reported to be issuing paper coupon<sup>^</sup> to their customers in their transactions of goods. Reserve Bank of India, however, have no information regarding wide circulation of paper coupons, in lieu of small coins.

(b) to(d) As stated above, the use of paper coupons has been in vogue in establishments lika hotels, canteens and shops for facilitating their transactions and not for replacing coins. Such coupons are not legal tender and there is no cause for any legal action.

SHRI O. J. JOSEPH: Sir, I would like to know whether the Government will take steps to supply in adequate numbers the small coins and currency of small denomination. It is because of sort supply that such things are gnfag on and cases of malpractice have come to light. What is the Timrty faced by the Govern-n'ci t in

of small coins end ciuweaey in smiill denomination?

SHRI JANARDHAN POOJARi: Steps have, taker: to import BO far as small coins are concerned. For the information of hon. Members. I can say that following steps have been taken. 9-hour working per shift in the 3 mints situated at Bombay, Calcutta and Hyderabad; installation of 22 new coin pressers. These pressers are to be installed from 15th of May and this will lead to additional production of about 300 million pieces per year; start of a second shift in Calcutta mint from 25th February 1985; introduction of cupro-nickel coins production in Hyderabad in March 1985. We have laken decision to set up a new mint at NOIDA in

SHRI VISHWA BANDHU GUPTA: Is the hon. Minister aware that in Delhi, not only paper money is being used but stamps, sweets and toffees are being used as currency? If you remember, I had brought this matter in detail to your notice but it appears no action has been taken in Delhi.

**JANARDHAN** POOJARI: Wherever possible, we are trying to improve the supply of coins.

SHRI V. GOPALSAMY; Mr. Chairman, there is a drought in the supply of currency of small denomination, particularly one rupee and two-rupee notes, and the currency which is in circulation is also totally damaged and torn out like this. This is the type of currency which is in circulation. This state of currency itself is the evidence of poverty conditions of the teeming millions. I would like to know from the hon. Minister as to why such type of currency is beine; allowed in circulation and what steps you are taking to solve the problem of shortage of small denomination

SHRI JANARDHAN POOJARI: I' share the concern of the hon. Mem25

her. So far as production of currency notes is concerned, we have taken steps as follows;

Modernisation and expansion currency notes press at Nasik additional ibalancing equipment installation at bank notes press at Dewas; shift working increased to 11 hours introduction of partial second shift in Dewas; full second shift in Dewas will start working by the end of May 1985; incentive scheme for production lias been introduced; sanction, in principle, of a new printing press.

SHRI V. GOPALSAMY: But the shopkeepers and taxi drivers refuse to accept such soiled currency notes.

SHRI JANARDHAN POOJARI: Sir, we know the plight of the people there. Through the Ahmedabad issue centre of the Reserve Bank of India, we have supplied coins to Gujarat State. Now, this year, in the year 1984-85, we have been able to allot coins worth Rs. 152.20 lakhs. This is against coins worth Rs. 134.90 crores allotted in the year 1983-84.

SHRI JANARDHAN POOJARI: Sir, we have taken steps and for the information of the' hon. House, I would like to say that in the year 1982-83, the production of coins was only 660 miliion pieces and in the year 1983-84, the production was increased to 1,063 million pieces. In the year 1984-85, up to 2.3.85, the production has gone, up to 1,240.44 million pieces. This is the step we have taken. Now, this is from the available capacity. We have also taken steps to set up a new mint. Not only that. I will give a brief history why this has happened. In the year 1977, I may be permitted to say,...you know, why I say in the year 1977...

MR. CHAIRMAN: No explanation.

SHRI JANARDHAN POOJARI: Sir, you also know as the former Finance Minister.

SHRI V. GOPALSAMY; There was no such problem in 1977.

SHRI JANARDHAN POOJARI: In 1977, the working hours were reduced from 60 to 64, per week. In the year 1978, they were reduced from 54 hours to 46 hours. There was no proper distribution system also. From the mints, during this period, the Reserve Bank of India did not lift the production. There was accumulation. The accumulation had gone up to such an extent that In the year 1978...

MR. CHAIRMAN: It does not matter. Now, try to improve.

SHRi JANARDHAN POOJARI: Afterwards, the Government of India was under the impression that available supply is more than the demand. At one point, the G werr.ment was compelled to take, a decision to stop the production at the Hyderabad Mint. Immediately, when the new Government came to power, this decision was withdrawn. We are talcing steps to improve the production. So far as supply is concerned, I can assure the House that within six months, we will improve the position and so far us the shortage of coins is toncemeo, it will tase

There are also complain'\*; that there is melting, to a certain extent, of coins and also that the coins are handed for selling them at premium. These are offences under the Small Coins Act and we have written to the State Government to take action under this Act.

SHRI JANARDHAN POO JAR]-There are reports from Delhi, Ahme daba-i, Bombay, Poona dnd Calcutta transport undertakings that they are issuing paper coupons. This is in the notice of the Reserve Bank oi India and to issue paper coupons i--' not an offence, the Resrve Bank cannot raise any objection. So far at the production and supply is concerned, J have alreadf replied the question.

SHRI H. L. KAPUR: Sir, we accept the explanation of the hon. Minister that the production capacity has 'been increased, but the fact still remains that there is shortage of coins and small coins, and this has accentuated further during the last five to six months than it was before. So, there is definitely something wrong Either the estimate is not correct or the supply position is not correct. What we would like to know from the Minister is, in spite of the capacity having been increased, what is the reason that the small coins are not available in the market and everyone is facing so much of difficulty?

SHRI JANARDHAN POOJARI: This part of the question also I have already answered.

MR. CHAIRMAN: Next question.
