Palace on Wheels' Train

- 427. SHRI DHULESHWAR MEENA: Will the Minister of RAILWAYS be pleased to state:
- (a) the total earnings from the prestigious 'Palace on Wheels' train during the year 1983-84 and 1984-85 and whether any amount out of this has been given to the Rajasthan Government, if so. what are the details thereof;
- (b) whether the train is presently being run only during a limited period, if so, what is the period: and
- (c) what improvements are likely to be made in the out-fit of this train to make it more popular and revenue earning?

THE MINISTER OF RAILWAYS (SHRI BANSI LAL): (a) The gross earnings during the season 1983-84 and upto 6th March, 1985 (during 1984-85 season) were Rs. 86.81 lakhs and Rs. 57.59 lakhs respectively. The earnings are proportioned between Rail ways and the Rajasthan Tourism Development Corporation in accordance with the agreed ratio.

- (b) The train runs during October to March only.
- (c) Steps are taken from time to time to improve the facilities provided on the train keeping in view the suggestions received from the tourists.

- (b) A s.heme for promotion of national integration through Community Singmg was launched in 1982 with the following objectives:
 - (i) Community Singing should inculcate patriotism and pride in our country and its glorious heritage.
 - (ii) Children should learn to respect and love all the languages and cultures which are interwoven into the fabric of India, including the work of great poets in various Indian languages, the strengthening the spirit of national integration.
 - (iii) Children must be taught to think of the common interest of the country and its people.

- (v) It should provide for a large number of people, an opportunity for artistic self-exres-sion and pride in belonging to the community.
 - positive (vi) India's contribu tion to tae cause of peace in the world should be brought out.

The main activities undertaken under this programme include organization of for training of teachers, camps preparation and duplication of casettes containing selected community songs, free supply of casettes and tape-recorders to teacher participants in training camps, free supply of tape-recorders and recorded casettes to various schools in States/ U. T.s and Kendriya Vidyalayas, bringing out various publications, evaluation of the work being done by teachers in the field of community singing, etc.

(c) Yes, Sir. The scheme has been extended to all parts of the country and is progressing towards achieving the desired re-. suits.
