Upliftment of Tribals in the country

- 532. SHRI RAM NARESH KUSHA-WAHA: Will the Minister of HOME AFFAIRS be pleased to state
- (a) what specific programmes were taken up by Goyernment during the sixth Five Year Plan period to uplift tribals in various parts of the country and what is the extent of achievement:
- (b) what amount of funds was provided during the Sixth Five Year Plan period for the purpose and what is the actual amount spent on 'the said programmes; and
- (c) what is the nature of the existing Centra! machinery, if any, to monitor the implementation of the programmes and to what extent it hag proved effective in carrying out its task?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRIMATI RAM DULARI SINHA): (a) The Tribal sub-Plan strategy adopted in the Fifth Plan was continued with full force during the Sixth Plan to provide a clear direction to the economic, social and educational advancement of the tribal people. During the plan period about 39,666 lakh tribal families were economically assisted to enable them to cross the poverty line.

- (b) The Sixth Plan outlay is estimated at Rs. 5535 crores and the amount is anticipated to be utilised during the plan period.
- (c) The Tribal Development Division of this Ministry is monitoring the implementation of the programmes which has proved effective in carrying out its task.

Plan of Punjab and Kashmir Extremists to step up their activities

- 533. SHRI RAM NARESH KUSHA-WAHA: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government are aware about the plan of the Punjab and Kashmir

- extremists to step up their anti-national activities and acts of terrorism in the country and abroad; and
- (b) if so, what are the details thereof and the action taken by Government in the natter?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRIMATI RAM DULARI SINHA): (a) and (b) Reports about the undesirable activities of extremist elements have come to the notice of the Government. Strict vigilance is being maintained in this regard by the authorities.

Resolution moved by India in the UNEP Meeting at Nairobi

- 534. PROF. C. LAKSHMANNA: Will the PRIME MINISTER be pleased to state.
- (a) whether India had moved a resolution on poverty, population and environment at the United Nations Environment Programme meeting on 28th May, 1984 at Nairobi which was adopted unanimously;
- (b) if so, what measures have been taken in India for its implementation and with what result; and
- (c) whether Government have introduced sewerages regulations, discharge of pollutants in rivers from industries and sir pollution and if so, with what results?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI VTR SEN): (a) Yes, Sir. A resolution on population and environment was moved by India and wis adopted.

- (b) The resolution envisaged the inclusion of the issue of population in relatioa to environment as a topic in the state of environment; report for the year 1985. Government of India is not expected to take any steps in pursuance of the resolution at this stage.
- (c) Guidelines for sewerage regulations have been framed for 12 Metropolitan cities. They are at various stages leading to enforcement of the regulation*. Mini-

mal mational standards have been fixed for 12 polluting industries. For others, standards are being formulated. Regulations have been framed under the Air Pollution Control Act. Out of 4109 large and medium industries 1966 units have installed pollution control equipment. Others are being pursuaded to adopt necessary measures. The Government has succeeded to a considerable measure in its effort*.

Percolation of the Benefits of electronic industry to the consumer

535. SHRIMATI MAIMOONA SULTAN. Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that tax concessions and relaxations from controls granted by Government to the electronic industry have not been passed on by t'hat industry to the consumers as was stated by him in his address to the seminar organise ed by the electronic industry on February 21, 1985;
- (b) whether any study has been conducted to find out how far the tax concessions could be passed on to the consumers; and
 - (c) if 10, the results thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECH NOLOGY AND IN THE DEPART MENTS OF OCEAN DEVELOPMENT, ATOMIC ENERGY. SPACE AND (SHRI **ELECTRONICS SHIVRAJ** PATIL): (a) In his address at the Seminar on Investment Opportunities in Electronics organised by AIMO in Delhi on February 21, 1985. Hon'ble Prime Minister had pointed out that many of the concessions, given to Industry including reductions in controls, have not been passed on to the consumer in the way that they should have been. However, as a result of the fiscal package announced in August, 1983 for electronics industry, the prices' of Compo-aents and Equipments were reduced by various manufacturers and Government had felt that CTV sets of 51 cms. screen size should be available for around Rs. 500o|. plus local taxes.

(b) and (c) While no detailed traily has been conducted covering the satire spectrum of electronics, Government have taken various steps to bring down the price of colour TV sets. These art given in the enclosed statement.

Statement

Various steps are being taken to bring down the price of Colour TV sets. Theee include:

- (i) Issuing industrial approvals liberally, without any upper limit on capacities so that economically viable level of production could be achieved ami competition encouraged.
- (ii) Reducing Government levies like customs duty on imported raw materials|componen,ts, reduction in excise duty, etc.
- (iii) Department of Electronics has set up a high power TV Coordination Committee under the Chairmanship of Secretary. Electronics with representation from Indian TV"Manufacturers Association. Electronic Component¹-Industries Association to review and monitor the progress of manufacturing of TV sets. The question of maximum price to be charged for a CTV set has been discussed in the various meetings of the above committee. In the meeting of this committee held on 16-8-1984. UMA committed that from 15th October, 1984, cost of the CTV to ihe enstomer with all taxes and one year guarantee in Delhi will not be more Rs. 7500 with electronic tuner and Rs. 7000 with turret

Further .in the meeting of this Commi-tttee held on 21-12-1984. ITMA was requested to advise all their members to provide the list of their CTV dealers all over India and their all inclusive customer price inclusive of one year warranty, of various models of CTV sets. TTMA agreed to do so. The lists would be made public.
