THE PRIME MINISTER (SHRI RAJIV GANDHI):(a) Yes, Sir.

- (b) The locality surrounding the site for the proposed joint venture hotel was not considered suitable for the type of hotel complex being envisaged.
- (c) The Chairman, ITDC alongwith the officials of the Tamil Nadu Tourism Development Corporation inspected the site before the decision was taken.
- (d) The State Government is on the look out for an alternative piece of land for the Joint Venture Hotel Project in question.

Thefts in trains

†506. SHRI PARVATHANENI UP-ENDRA: Will the Minister of HOME AF-FAIRS be pleased to state:

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI-MATI RAM DULARI SINHA). (a) to (c) As the subject 'Public Order' and 'Police' are in the State List of the VIIth Schedule of the Constitution, it is the responsibility of the State Governments and Union Territory Administrations to enforce law relating to offences. No data in regard to thefts of passengers' property and baggage and pick-pocketing and other details thereof is compiled on all India basis. Therefore, there is no data avail-

ť

able to show that such incidents are on the increase and about the number of cases of theft and the restoration of property to the passengers.

(d) No compensation is paid to victime passangers for theft of their personal property and baggage.

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI K. R. NARAYANAN): (a) Proposals for Rural Development were received from the State Government of West Bengal as a part of the Annual Plan proposals for 1985-86 for the State.

- (b) The proposals relate to Centrally Sponsored Programmes such as Integrated Rural Development Programme and National Rural Employment Programme and other Rural Development Programmes like Community Development & Panchayats and Land Reforms.
- (c) The proposals were received in January, 1985.
- (d) to (g) The Annual Pian proposals for 1985-86 of all State Governments including the Government of West Bengal are to be discussed with the State Government and finalised shortly.

Trekking Programme in the country

- 509. SHRI DIPEN GHOSH: Will the PRIME MINISTER be pleased to state:
- (a) whether there is any proposal under Government's consideration of organising trekking programme in the country;
 - (b) if so, what are the details thereof;
- (c) whether Darjeeling is one of the proposed sites for trekking;

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT):

(a) to (f) The Department of Tourism

does not itself organise trekking programme in the country. However, for the development and promotion of trekking in the Himalayan States' the Department provides assistance for the purchase of equipment and other infrastructural facilities. During 1982-83 an amount of Rs. 1.52 lakhs was released to the Government of West Bengal for purchase of trekking camping equipment for Darjeeling in the Himalayam Region.

The Department is also taking up the construction of 5 trekkers' huts in Phalut-Sandakhphu trek-route in Darjeeling area. An amount of Rs. 4.00 lakhs was released during the current financial year out of the total estimated cost of Rs. 7.88 lakhs of this project.

The Department of Tourism has prepared and circulated various trek-routes in the country including Darjeeling to our offices in India and overseas with a view to promoting and publicising these trek-routes.
