Almost 80% of 99 ships detained were above 25 years of age, and out of the total number of 653 inspections carried out about 30% were above 25 years of age.

#### **Roads constructed under Highway Plan**

Will the Minister of SHIPPING, ROAD TRANSPORT AND HIGHWAYS be pleased to state:

the length of the roads constructed till December, 2006 as Cabinet approval for construction of 5,000 km. under the Highway Plan was accorded in December, 2003;

whether the annual targets fixed for North-South and East-West corridors have been achieved;

if not, whether there has been any cost-over-run or time-over-run; and

if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING, ROAD . TRANSPORT AND HIGHWAYS (SHRI K.H. MUNIAPPA): (a) In December, 2003, Government had approved for undertaking 4/6 laning of 6,195 km length of National Highways (NHs) under National Highways Development

Project (NHDP) Phase-II. These projects are at various stages of implementation. Out of this an aggregate length of 29 km was completed till December, 2006

NHDP Phase-II is targeted for completion by December, 2009.

and (d) The cost-over-run for NHDP Phase-II would be known only after its completion.

However, The World Report on Road Traffic Injury Prevention of World Health Organization in 2004, *inter-alia*, recommended that all the Governments may assess the current status of Road Safety in their country, review policies, institutional arrangements and capacity and take appropriate action. Further, for the low income and middle income countries with limited human and financial resources it is suggested to work with international or Non-Government Organization or other partners to implement the recommendations. The main recommendation of the World Report on Road Traffic Injury Prevention of World Health Organization in 2004 are as under:—

- (i) Identify a lead agency in government to guide the national road traffic safety effort.
