(a) whether it is a fact that under the modified Master Plan for Delhi, only essential Central Government offices will be located in Delhi; and

(a) and (b) Perspective Development Plan-Delhi, 2001 prepared by the Delhi Development Authority proposes a restrictive policy on employment generation and location of Government offices in Delhi to check the rapid population growth of Delhi Metropolis.
