THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VEEREN-DRA PATIL): (a) The price of alcohol is reviewed from time to time on the basis of cost studies done by the Bureau of Industrial Costs & Prices. This takes into account factors, like cost of raw material, inputs, such as molasses, cost of utilities, such as steam and other relevant factors, including reasonable costs of conversion.

Supply of sub-standard medicines

857. SHRI RAMCHANDRA BHARD-WAJ:

SHRI J. P. GOYAL:

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state;

- (a) whether Government's attention has been drawn to a press report captioned 'Sarkari Karkhane Se Ghatiya Dava Ki Supply' (Supply of sub-standard medicines from Government Factory) which was published in the 'Navbharat Times' dated the 10th March, 1985; and
- (b) if so, what are the details thereof and what action has so far been taken in the matter?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VEEREN-DRA PATIL): (a) Yes, Sir.

(b) Hindustan Antibiotics Limited purchased 8 batches of imported Tetracyline bulk drugs from Indian Drugs and Pharmaceuticals Limited in May, 1977 took delivery even before testing because of immediate requirement. The material was tested by Hindustan Antibiotics Limited in its Quality Control Laboratory and found satisfactory. Based on this, a part of the bulk drug was taken up for processing and capsules prepared were supplied to the Army. These were returned by the Army as they developed colour. In the meantime, the test report of the Drug Controller was received by the Indian Drugs and Pharmaceuticals Limited which indicated that four batches were of substandard. Part of the material was returned to Indian Drugs and Pharmaceuticals Limited and replacement received subsequently. The other part was reprocessed to Indian Pharmacopies (IP) specification making used for and human and veterinary formulations. The capsules returned Army were also reprocessed to IP specification and disposed of. No complaints were received in this regard. During reprocessing of the sub-standard bulk drug and the capsules there were certain material losses.
