Complaints of Mismanagement in Annual Training Camp

1029. SHRI SYED AHMAD HAS-HMI: Will the Minister of DEFENCE be pleased to state:

(a) whether some complaints regarding mismanagement, misappropriation of funds and indiscipline in organising in January, 1985 the Annual Training Camp of NCC Battalions of Mainpuri and Firozabad, have been received:

(b) if so, what are the details thereof; and

(c) the remedial steps taken by Government?

THE MINISTER OF DEFENCE (SHRI P. V. NARASIMHA RAO):

(a) One complaint was received in February, 1985 alleging irregularities and indiscipline in a combined NCC Camp of the NCC Units of Mainpuri and Firozabad.

(b) The complaint has alleged irregularities generally in the conduct of the Camp and in the purchase of fire-wood and coal. According

to the complaint, cadets were given substandard food and adequate arrangements were not made for living tents, washing point or medical coverage.

(c) The complaint is under investigation.

Appointment of Nursery Teachers in Delhi
