Provocative material published in these newspapers has been brought to the attention of the British authorities as and when necessary. A number of further steps have also been taken to counter hostile propaganda. New Air-field at Itanagar

(a) whether it is a fact that the Arunanchal Pradesh Government submitted a proposal for constructing air-field -at Itanagar for domestic commercial flights;

(b) whether Government have taken any action in this regard; and

(c) by when the construction work is likely to start?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION: (SHRI ASHOK GEHLOT): (a) and (b) Yes, Sir. A site near Naharlagun for the construction of a STOL airport was identified and inspected by a team of officers of the Department of Civil Aviation and Central Public Works Department in January, 1981 and the State Government was requested to acquire the land and transfer it to the Department of Civil Aviation, free of cost. The State Government subsequently indicated that it was not possible to acquire the land and suggested a site near 'DOIMUKH' as an alternative. A team of officers is being deputed to inspect the site.

(c) The time schedule of the project will be determined after the selection of a suitable site and after obtaining the requisite approval to the cost estimates.
