(4) Rehabilitation of Endangered and Threatened Species.

(5) Captive Breeding Programmes.

(6) Wildlife Education and Interpretation.

(7) Research and Monitoring.

(8) Domestic Legislation and International Conventions.

(9) National Conservation Strategy.

(10) Collaboration with Voluntary Bodies.

(c) The different activities proposed under the Action Plan cover the entire country, including Rajasthan.
